NATIONAL COUNCIL FOR HIGHER EDUCATION (REGISTRATION OF HIGHER EDUCATION INSTITUTIONS) (COLUMBIA COMMONWEALTH UNIVERSITY AND RIVERTON UNIVERSITY (REVOCATION) ORDER, 2019

IN EXERCISE of the powers conferred by section 23 (2) of the National Council for Higher Education Act, I, BRIGHT MSAKA, SC, Minister of Education, Science and Technology, on the recommendation of the National Council for Higher Education, hereby make the following Order—

- Citation 1. This Order may be cited as the National Council for Higher Education (Registration of Higher Education Institutions) (Columbia Commonwealth University and Riverton University (Revocation) Order, 2019.
- Revocation of registration 2.—(1) (a) The registration of Columbia Commonwealth University is hereby revoked for failure to carry out its objects, not carrying out its functions properly and is in the interest of higher education in Malawi that its registration should be revoked; and
- (b) this Order shall not affect the validity of any certificate, diploma, degree or other academic qualifications conferred or awarded prior to 29th October, 2018.
- (2) (a) The registration of Riverton University is hereby revoked following the notification to the National Council for Higher Education of a merger of its operations with those of Exploits University; and
- (b) the merger became effective before Riverton University had completed an academic cycle or awarded any qualification, and therefore no qualification purported to be awarded by Riverton University shall be recognized in Malawi.
